THERE WILL BE NO ON-SITE REGISTRATION. You may mail your registration form to the address that is on the Parade application form and they must be received by Wednesday, December 4, 2019 or you may come to the Fair Grounds Office on Saturday, December 7, 2019 between the hours of 9:00 am to 12:00 (noon). The parade line-up will be done at that time. There is a map on the other side of this letter.

You may not have any Santa Claus with your group.

There will be a parade representative at the **entrance** to the parade line-up between 12:30 and 1:30. You must have a representative of your group check in during that time to receive your number for placement in the parade. **Please do not move from that placement.** This will only cause confusion at the reviewing stand for the announcers trying to identify your entry.

## The parade will start at 2:00 p.m. SHARP!

The line-up will be behind the Fox Run Shopping Center and you will proceed around K-Mart and continue in front of the stores going towards the other end of the shopping center. Each group will have an opportunity to present a 150 word description of their entry and a performance in front of the reviewing stand. If your group plans to perform before the reviewing stand, please indicate on the narrative section of the parade registration form.

Fill out the section of the registration form entitled "ANNOUNCEMENT". This is the information that the announcer will read to the audience about your group and its performance. Please be brief, but be informative. If you have any requirements such as being placed next to Fire Trucks/Bands/Horses, etc., it is necessary for you to pre-register so we can do our best to accommodate your request.
